In consideration of being permitted entry on property of Central Kentucky Gun and Range, LLC where bows and arrows and loaded firearms will be used and fired, included but not limited to firearms loaded with reloaded, remanufactured, and/or "homemade" ammunition, and where explosive/flammable supplies will be present and in use, to being allowed to observe and/or participate in activities on these premises in which such items are present and/or in use, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, in addition to paying any entry, participation or membership fee in any event or entry into the premises, if any such fee is required or has been paid that I hereby agree upon behalf of myself, my estate, my heirs, assigns, next of kin, and any other party or parties who might otherwise have a claim arising from my injury and/or death, including but not limited to any claim for loss of consortium, to the following:

I hereby release and exonerate Central Kentucky Gun Club, LLC, also known as Central Kentucky Gun and Range, its owners, directors, officers, employees, agents, and assigns, from any and all liability for their individual or collective ordinary negligence or gross negligence which results in future personal injury, whether physical or mental/emotional, disease, or death, to me or, if I am pregnant or nursing, to my unborn or nursing child OR children, as well as any property damage. This release includes but is not limited to releasing the said parties from liability for any negligence (ordinary negligence and gross negligence) on the part of any persons or organizations including Central Kentucky Gun Club, LLC A/K/A Central Kentucky Gun and Range, its owners, directors, officers, employees, agents, or assigns, resulting in my being: gunshot; struck by ricochet, fragments of projectiles or firearms, and/or other items struck by gunfire, loud and/or repeated noise, exposure to lead and/or other harmful substances, and/or shock; as well as any injury, disease and/or death arising from falling, exertion, stress, and/or medical treatment. I further intend this document to cover any injury including death from any explosion.
